

The Croatian Audiovisual Centre, Kralja Zvonimira 20, 10000 Zagreb, Croatia, represented by the Chief Executive Officer Mr. Hrvoje Hribar

and

the Danish Film Institute, Gothersgade 55, 1123 Copenhagen, Denmark, represented by the Chief Executive Officer, Mr. Henrik Bo Nielsen _____

(hereinafter referred to respectively, as "HAVC" and "DFI", and collectively as "The Parties");

Acknowledging the rich cultures and traditions of Croatia and Denmark in the field of audiovisual production;

Desiring to further promote the close and friendly relations between Croatia and Denmark in the audiovisual sector;

Affirming the audiovisual culture as a basis for mutual understanding and cooperation in artistic, economic, and social spheres between Croatia and Denmark;

Recognizing the contribution and benefit of exchanges and cooperation in enhancing their mutual understanding and friendship;

Have agreed to the following

MEMORANDUM OF UNDERSTANDING

Article 1 SCOPE OF COOPERATION

The Parties will promote exchanges and cooperation in the field of audiovisual activities both tangible and intangible in accordance with their respective domestic laws, regulations, policies, administrative guidelines and procedures.

Article 2 ACTIVITIES

The Parties will actively promote greater awareness, understanding and appreciation of each other's audiovisual arts, culture and industries through collaboration and exchange, joint research and study, exchange of information and interpersonal exchange and interaction.

The Parties will encourage and support already established links and working relationships between Croatian and Danish film production companies, whilst actively seeking to widen the scope of collaboration.

The Parties will encourage and support human resources development in the fields of audiovisual creativity and audiovisual heritage.

The Parties will enhance the cooperation in the areas of audiovisual enterprise and audiovisual industries through product development, promotion of the audiovisual market, exchange of information and networking among experts.

The Parties will endeavor to identify and address common concerns regarding HAVC-DFI cooperation relative to multilateral treaties and international conventions.

All activities shall be performed in good faith, safeguarding the interests of both Parties.

Article 3 IMPLEMENTATION

The Parties agree that project formulation, monitoring and evaluation will be carried out through the cooperation mechanisms established under the HAVC-DFI dialogue relations.

To ensure the implementation of this Memorandum of Understanding, the financial obligations and arrangements for the projects will be discussed and agreed to by both Parties.

Article 4
COPYRIGHT

The protection of copyright within the jurisdiction of each Party will be enforced in conformity with its domestic laws, regulations, administrative policies, guidelines and procedures and also with the international agreements to which Croatia and Denmark are Parties.

Article 5
DISPUTE SETTLEMENT

Any dispute between the Parties on the interpretation and implementation of this Memorandum of Understanding will be settled amicably through consultations and negotiations between both Parties.

Article 6
AMENDMENT

This Memorandum of Understanding may be amended only by mutual consent between the Parties in a written form and it will come into effect from the date of its signing.

Article 7
ENTRY INTO FORCE, DURATION, AND TERMINATION

This Memorandum of Understanding will come into effect on the date of its signature by both Parties.

This Memorandum of Understanding will be in force for the period of *three* years and will be extended/renewed/amended following the review carried out by mechanisms established under the HAVC-DFI dialogue relations.

The termination of this Memorandum of Understanding will not affect the validity or fulfillment of any on-going programs and projects that have been agreed by the Parties before the termination.

Article 8




